Dear Congressman Guest:

Please find enclosed the City of Brandon's FY25 Community Project Funding request for the City of Brandon's Cornerstone Water Tank and Distribution Project. As Mayor of Brandon, I want to express our gratitude for your support of our pursuit of State and Tribal Assistance Grants (STAG) funding.

This funding request is critical toward ensuring the City of Brandon continues to provide safe, reliable, clean, and high-quality water in an equitable manner to all our residents. Brandon has been proactive over the past 10 years in approaching the water supply challenges of a 200 year old city. In 2017 the city had a capacity rating of 96.8% (meaning the city used nearly 100% of available well water daily) from the Mississippi State Department of Health (MSDH). The city took an aggressive and proactive approach over the next four years by investing over \$5 million into the system and by 2021, the rating improved to a capacity of 64.1%.

This approach has not ended. The city is continuing to proceed forward with an additional \$9 million investment into the system with new waterlines, a new well and a proposed 750,000 gallon tank. This work is currently being funded through both the State Revolving Loan Fund and through a USACE Section 592 grant. Runaway construction costs in this economic environment has greatly diminished our ability to further expand our system. Due to the increase in construction costs, the city is requesting assistance through the STAG program to help with completing these much needed projects. This area of the city (north east quadrant) is currently only served by water from one well over a mile away, and this project is critical to our goal of ensuring safe and reliable drinking water by providing a constantly reliable water supply necessary in a modern, looped water main system.

Thank you for your continued leadership in Congress, and your continued support of the City of Brandon.
