Dear Chairman Cole and Ranking Member DeLauro:


I am requesting funding for the City of Meridian for Water Storage Facility Project in Fiscal Year 2026. The entity to receive funding for this project is the City of Meridian located at 311 27th Avenue, Meridian, Mississippi, 39301. The funding would provide for a new water storage facility in the City's Medical District to ensure safe and sufficient water is available for critical water use. The Medical District includes two hospitals and several medical offices and serves 230,000 people within a 45-mile radius of Meridian, including two military facilities—Naval Air Station Meridian and Key Field. This project is an appropriate use of taxpayer funds because the Medical District has experienced outages that interrupt service to the medical facilities that need water, especially for life-critical activities such as dialysis and surgeries; and it is critical for the Medical District to have reliable water infrastructure as it serves patients from Meridian, West Alabama, and nearby military facilities.

This project has a Federal nexus because the funding provided is for purposes authorized by Section 1452 of the Safe Drinking Water Act, 42 U.S.C. 300j-12.

I certify that I have no financial interest in this project, and neither does anyone in my immediate family.
